When appropriate, Mr. Baer has the tenacity to litigate a matter to conclusion through trial or appeal, where he has a proven track record of success. He prevailed in overturning the trial court judgment in *Murphy v. Murphy* (2008) 164 Cal.App.4th 376, the first case in the nation to hold that a substituted judgment order approving a conservatee's estate plan bars any beneficiary from contesting the plan after the conservatee's death.

Mr. Baer is one of the authors of California Trust Litigation, Matthew Bender's practice guide. His chapter on contesting and defending the validity of trust instruments is the definitive resource on this topic for attorneys practicing in California.
